#### NOTICE FOR EMPANELMENT

General Administration Section of Canara Bank, Circle Office, Ranchi is managing Bank's branches/office premises at various locations of the state of Jharkhand. The intention of this notice of empanelment is to maintain a separate panel of various contractors/vendors/suppliers/firms under various categories for various types of works as and when required by the bank.

- 2. Generally, the routine works of the Bank are awarded/procurements are made by calling competitive tenders/quotations from the empanelled contractors/ suppliers and in case of emergent works/ works of small magnitude, the Bank may opt to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work on nomination basis and also has the right for open tendering process for any particular work, depending on the nature & magnitude of the work.
- 3. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexures but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
- 4. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- 5. Documentary proof with respect to the prequalification criteria shall be furnished along with the application form. In this regard, copies of the work orders and completion certificates and or such other documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.
- 6. The authorized person of the firm/ company shall sign in all the pages of the application with seal of the company/ firm.
- 7. The empanelment will be made for a specific category depending on the credentials submitted. However, the applicant empanelled in higher category shall be eligible for works in the lower category.
- 8. All doubts regarding the empanelment shall be clarified during pre-bid meeting and any requests for rectifying any lacunae/deficiency in the bid or supporting documents not submitted shall not be entertained and bank shall not take / allow additional documents after submission / acceptance of tender bid document.

- 9. The evaluation will be based on the experience, reputation, empanelment with other Banks, PSUs, Govt institutions, manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc and if found necessary may also include inspecting the works undertaken by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. The empanelled contractors will only be informed by post/mail.
- 10. If the information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- 11. The Applicants must have their office in the geographical jurisdiction of the State of Jharkhand.
- 12. The empanelment shall be valid for a period of three years w.ef 01.04.2023 i.e till 31.03.2026 subject to performance review every year.
- 13. Applications received after the due date and time are liable for rejections.

- 15. Sufficient security equipment stock has to be held in the office of the service provider situated in Jharkhand to enable them to install CCTV/Burglar Alarm/Fire Alarm etc. within 2 working days. If this clause is not adhered and there is any delay caused due to non-maintenance of stock in office based in Jharkhand, the vendor shall be barred from applying for any work under CO: Ranchi or may even be de-empanelled.
- 16. The security equipment service providers shall maintain on their

payroll such number of technicians required so as to give the Bank the requisite service at the stipulated time. If the vendor fails to do so, the Bank reserves the right to cancel any / all the orders awarded to the vendor and /or de-empanel the vendor.

- 17. Circle Office Ranchi has jurisdiction over all branches, ATMs and administrative offices in the state of Jharkhand including three (03) presently functioning Regional Offices at Ranchi, Jamshedpur & Dhanbad and one (01) to be opened shortly at Hazaribagh. Separate panel of security equipment service providers will be maintained for each Regional Office and vendors should clearly list their preference for which they should be considered. This shall be dependent upon their sales & service network, staff location and availability , proximity to their Jharkhand office etc. Duly deliberated decision of the Bank regarding the allotment shall be final and no further representation in this regard shall be entertained.
- 18. A list of approved rates shall be maintained by the Bank by taking L-1 rates of all the equipment components for any urgent/immediate work. Bank can also award higher value works on the basis of sealed cover quotation/limited/Open Tender.
- 19. The present empanelment is mainly for works for value upto the limits mentioned in respective categories. In case of any high value / other works, Bank may undertake the works by project specific prequalification exercise.
- 20. Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever. In this regard, no telephonic query or any letter/ petition will be entertained.
