Other Techno – Commercial criteria to be fulfilled to qualify for opening of Financial Bid:

- 1) The firm should in the business of Supplying and Installing Strong Room Doors for not less than 5 years.
- 2) The firm should have annual average turnover of not less than 250 Crores for the last 3 financial years.
- 3) The firm should have earlier supplied the Strong Room Doors for Government bodies/Public Sector Banks.

Technical Parameters to be met by the participating firms:-

- 1) The Strong Room door should be of TRTL 30 – FR 30 grade.
- 2) The Strong Room door should be certified and labelled as per IS 11188:2014.
- 3) The door should have double locking mechanism with 9 lever lock.
- 4) Door should have minimum clear opening of 900mm x 1950mm.
- 5) The door should be accompanied with iron grill gate.
- 6) The size of the air-ventilator should be minimum 450mm x 450mm.

Terms and conditions

1. The firm should account the expenditure towards shifting the door and ventilator to the respective sites within the amount quoted and nothing extra will be paid towards the shifting charges.
2. The firm will be held responsible for any damage to the premises while shifting the Strong Room Door unless and otherwise conveyed to the Bank about the prospective damage after making the site survey.
3. The firm should arrange for site visit at their own cost before participating in the tender.
4. Retention Money Deposit amount of 10% of the base amount of the tender will be deducted at the time of final payment which will be released within fourteen days after completion of defect liability period of 1 year from the date of satisfactory installation of the Strong Room Door and Air-Ventilator. However, the amount can be released upon submitting the Performance Guarantee of the amount equal to the base amount for the entire contract for that particular firm.
5. There is a provision to split the order among the L1, L2 and L3 firms in the ratio 50%, 30% and 20% at L1 rates as per discretion of Bank rounding to the nearest integer.
6. In case there is no provision to shift the door inside the premises without making certain modifications, same shall be taken up with the Bank in advance.
7. In case it is found at a later stage during arbitrary testing that there is deviation in the specifications of the door provided then the firm will be de-empanelled from Canara Bank till further notice.
8. The amount quoted should be exclusive of GST amount which shall be paid separately by Bank.
