



OVERVIEW:

The 10% Instant Discount Offer ("Offer") is a promotional offer administered and offered by NPCI ("RuPay") in partnership with Reliance Retail Limited ("AJIO") on www.Ajio.com ("AJIO Website") and on AJIO mobile application ("AJIO Mobile App") (collectively referred to as "AJIO Platform") on purchase of specified products displayed on the Platform ("Specified Products") using Credit Card of RuPay ("RuPay Credit Card holders").

OFFER TERM/ PERIOD:

Unless terminated earlier as provided under the Agreement, this Offer shall commence starting from 22nd August 2025 at [00:00:00 Hrs.] ("Offer Start Date") and continue until 31st October 2025 at [23:59:00 Hrs.] ("Offer End Date") or such other date and/or time as may be determined by AJIO at its sole discretion. The period starting from Offer Start Date until Offer end Date shall be referred to as Offer Term/ Period. During the Offer Period, there can be a blackout of the visibility of the Offer on AJIO Platform due to certain tactical business exclusivity reason.

ELIGIBILITY

- This Offer is open to all individual legal residents of the Republic of India aged 18 or above ("Resident Individual") on the Offer Start Date.
- Each Resident Individual who is **RuPay Credit Card holder** and is AJIO customer with a valid phone number and e-mail address ("**User**").

OFFER DETAILS:

- 1. 10% Instant Discount Offer will be applicable on eligible RuPay Credit Cards ("RuPay Credit Cards") only.
- 2. 10% Instant Discount Offer will be available to RuPay Credit Card holders on usage of RuPay Credit Cards for purchase of Specified Products on the Platform on minimum order value of Rs 4,500 ("Minimum Order Value") and up-to a maximum discount capped at Rs. 1,000 ("Maximum Discount Value").
- 3. Minimum Order Value for determining eligible transactions shall not be subjected to partial return or partial cancellations during reconciliation process for billing purpose to RuPay.
- 4. Subject to the terms contained herein, the Offer can be availed once per eligible RuPay Credit Cards per months (i.e., once in each month of August, September, and October 2025) during the Offer Term but the total Maximum Discount Value per RuPay Credit Cards will be capped

- 7. The Instant Discount Offer cannot be combined with any other promotion offered by AJIO and/or RuPay on AJIO Platform.

MISCELLANEOUS:

If the User who has availed the Instant Discount Offer, return all or part of the Specified Products purchased by them on the Platform, such that the value of their order falls below Rs. 4,500, they will not be eligible for return of purchased Specified Products. All products returned by the User shall be entertained solely as per AJIO's prevailing product return policy.
- 2. The Offer shall also be subject to AJIO Platform terms and conditions including but not limited to Platform Terms and Conditions, Fees & Payments, Cancellations, Returns and Refunds, etc. and such additional terms and conditions as the Reliance may notify from time to time.
