 - ii) Photocopies of PAN Card, ID Proof and Address proof. However, successful bidder would have to produce these documents in original to the Bank at the time of making payment of balance amount of 25% of bid amount.

Sale shall be confirmed in favour of the successful bidder, subject to confirmation of the same by the secured creditor.
