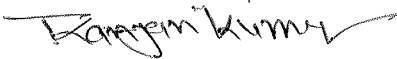

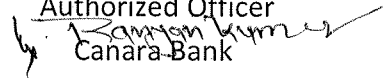

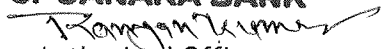
SPECIAL INSTRUCTION / CAUTION
