Candidates belonging to EWS category are required to submit valid EWS certificate as per Government of India format. Those candidates who fail to submit the required original documents will not be allowed to join the Bank.

The Appointment Order and information regarding joining will be sent to the candidates individually to their registered email provided by the candidates at the time of registration. Any request for modification in email id will not be entertained and candidates shall make their own arrangements for receipt of the same.

The list of candidates whose provisional selection is kept withheld for the above post is also furnished. The reasons for the same will be informed to the concerned candidates through their registered email ID.
