- c) The property will be sold for the price which is more than the Reserve Price and the participating bidders may improve their offer further during auction process.
- d) EMD amount of 10% of the Reserve Price is to be deposited in **E-Wallet of M/s PSB Alliance Private Limited (E-bkray) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan** on or before **12.11.2024**.
- e) Intending bidders shall hold a valid digital signature certificate and e-mail address. For details with regard to digital signature please contact the service provider **M/s PSB Alliance (Ebkray)**.
- f) After payment of the EMD amount, the intending bidders should submit a copy of the following documents/details on or before **12.11.2024** between 10:00 am to 4:00 pm., to Canara Bank, **Bardoli** Branch by hand or by email.

Sale shall be confirmed in favor of the successful bidder, subject to confirmation of the same by the secured creditor.
