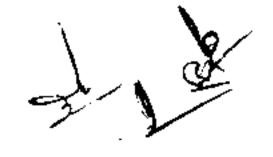

B. SCOPE OF EMPANELMENT

- a) Empanelment would be for following items:
 - i. Various types of Servers
 - ii. Desktops with / without TFT Monitors / Thin Clients
 - iii. Laptops
 - iv. Printers
 - v. Scanners & Other Computer items
 - vi. System & Off-Shelf Software
- b) During empanelment period, Bank reserves the right de-empanel any vendor. Bank's decision will be final in this regard.
- c) During the empanelment period, Bank will float limited tenders amongst the empanelled vendors and seek responses for various requirements. Individual tender/s will contain detailed terms & conditions, instructions and scope of work. Such limited tenders shall be floated either by DIT Wing, Head Office or by Circle Offices. Bank may float limited tenders for Rate Contract towards supply of Desktops, Printers (Dot Matrix Printers, LaserJet Printers, Pass book printers, Color Printers, Line Printers and Cash Receipt Printers) and Scanners across the country.
- d) If the service provided by the vendor is found to be unsatisfactory or if at any time it is found that the information provided for empanelment or for any tender is false or if irregularities shown by the vendor when applying for the tenders, the Bank reserves the right to remove such vendors from the empanelled list without giving any notice to the vendor in advance.
- e) Empanelled Vendors not submitting their response continuously for 3 limited tenders may be de-listed from our empanelment list at the discretion of the Bank.

C. EMPANELMENT PROCEDURE

The vendor will be empanelled as per the following process:

- a) Bidders satisfying the eligibility criteria and have submitted the EMD and application fee will be short listed and will be empanelled with the Bank after due scrutiny of documents submitted by the bidder.
- b) Empanelment would be done nationally.
- c) The Bidder who has not satisfactorily completed any of the earlier contracts with Canara Bank will not be eligible for participation in this empanelment.
- d) The empanelment will be valid for one year or till the completion of next empanelment process.

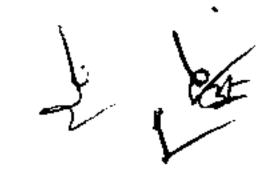
