3	Q	In the case of single debit in account with multiple credits, whether the payee name/ account number/ branch/ bank are recorded in the passbook?
	A	No. In the case of single debit in account with multiple credits, the payee name/ account number/ branch/ bank will not be recorded. However, the fact of "multiple payees" is indicated in the passbook.
4	Q	What details are provided in the passbook for payments made to the account holder?
	Α	The following details are provided in passbook for payments to the account holder:
		i)'Self' is indicated as payee ii)Name of the branch if payment is made by other than base branch.
5	Q	What details are provided in the passbook for issue of Drafts/Pay Orders/Any other payment instrument?
	А	The following details are provided in passbook for issue of Drafts/Pay Orders/any other payment instrument:
		i)Name of the payee (in brief) ii)Name of the drawee branch.
