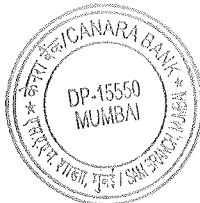

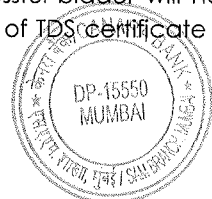
6. Other Terms and conditions :
