- f) Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of Rs.1,00,000/- For Property no 1 & Rs.10,000/- For Property no 2 (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1).
