The undersigned proposes to sell the assets (through e-auction) more fully described in the Schedule of Sale Notice.

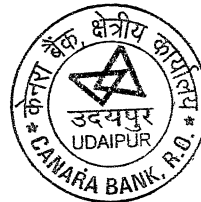

This is without prejudice to any other rights available to the Bank under the subject, Act or any other law in force.

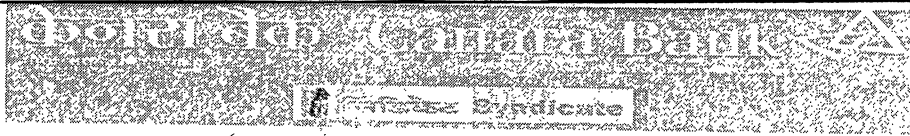
