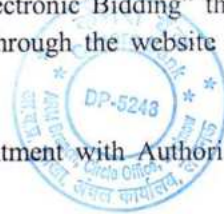

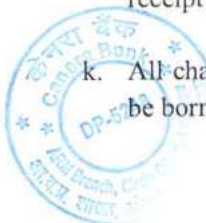
6. Other terms and Conditions:
