 - (ii) *On 11.12.2020, allotted 19,32,36,714 equity shares of face value of Rs.10/- each at an Issue Price of Rs.103.50 (including premium of Rs.93.50) per share aggregating up to Rs 2000 Crores to eligible qualified institutional buyers, in accordance with the applicable provisions.*
