b) The property can be inspected, with Prior Appointment with Authorized Officer, on 06.03.2025 (10:00 am to 5:00 pm).

c) The property will be sold for the price which is more than the Reserve Price and the participating bidders may improve their offer further during auction process.

d) EMD amount of 10% of the Reserve Price is to be deposited in **E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to**

deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before 10.03.2025.
