➤ Life Certificate (LC) for the year 2021

Pensioners who are yet to submit the LC are requested to submit their LC immediately at any of the Branches or to submit their Digital LC (DLC) using Jeevan Pramaan through various modes mentioned below:

- ✓ Door Step Banking (DSB)
- ✓ Any of our Branches

➤ Life Certificate (LC) submission status made available in "Canarites" App

Through "Canarites" App, Pensioners can view their Profile, Pension Calculation, Pension disbursement details, Investment Details, Link to Form No.16 and Ex-employees page from Bank's Website. Now, we have updated the App to display the LC submission status also. Further, we intend to include few other features in the said App for the benefit of Pensioners. As such, Pensioners are requested to download "Canarites" App from the following link and make use of the facilities made available in the App.

Pensioners who are already using the App may download the latest update to view LC submission status.

➤ Investment Proof to be submitted for the FY 2021-22

Pensioners who have already submitted the investment declaration for the FY 2021-22 are required to submit Proof of Investments for the same, to reach Pension Fund Section on or before 31.12.2021. Please note that the Pension from January 2022 onwards will be paid on the basis of Proof of Investments submitted and not on the basis of Investment declaration. Pensioners may submit the scanned copy of the investment proof through email to hopenfund@canarabank.com or submit hardcopies of the same by post/courier to Pension Fund Section. We request the Pensioners to adhere to the timelines and submit the proof of investment by 31.12.2021.
