- **TDS ON ACCOUNT OF DR REVISION w.e.f. 01.08.2023:** Monthly pension of ex-employee pensioners will increase post DR revision w.e.f 01.08.2023. Due to this increase, for those pensioners whose projected net taxable pensionary income is crossing Rs. 5 lakhs (under Old Tax regime) and Rs. 7 lakhs (under New Tax regime) for this FY, there will be deduction of applicable Tax from their monthly pension from August month onwards.
