- ➤ <u>USAGE OF CANARITES APP</u>: EX-EMPLOYEE PENSIONERS CAN DOWNLOAD THE "CANARITES" MOBILE APP BY VISITING GOOGLE PLAY STORE (ANDROID PHONE USERS) OR APP STORE (IPHONE USERS) AND SEARCH FOR "CANARITES" OR THEY CAN DOWNLOAD THE SAME BY VISITING THE BELOW MENTIONED LINK:

Now Ex-employee pensioners can also view their LC updation status, last 12 months pension disbursement details & name of their spouse, in addition to their Profile, Pension details, Disbursements details & Investment details. Further, some more features are under development. Ex-employee pensioners can view the email-id updated in the pension records through Canarites app. In case of any discrepancy, they are advised to take up with Employees' Pension Fund Section. Ex-employee Pensioners are advised to download & use the "Canarites" app.

➤ LIFE CERTIFICATE THROUGH VCIP: Vide our Vishranthi Newsletter Vol.31 dated 27.10.2021, we have enumerated various modes/methods for updation of Life Certificate by our Ex-employee pensioners. Now, we have introduced an option to update the Life Certificate through VCIP (Video Based Customer Identification Process) by our Ex-employee pensioners & their Family pensioners. For LC updation through VCIP, pensioners will not be required to visit any Branches / Offices and it can be done at their Home comfortably through the help of an Internet enabled Smartphone. Detailed guidelines regarding VCIP is advised vide our Circular No. IC/65/2022 dated 05.02.2022.

## Salient Features of VCIP Facility:

- The process involves Identification of pensioner, capturing of PAN Card, Adhaar, Signature & location of the pensioner. On completion of VCIP process, Life Certificate will be updated in HRMS package automatically.
- VCIP facility is for pensioners who are residing in India.
- No charges for availing this facility.

## Requirements for Pensioners:

- Smartphone (Android/IOS) with internet facility (Preferably a speed of 2 Mbps and above).
- Mobile number should be registered with Aadhaar and Bank records.
- Original Aadhaar Card & PAN Card.

#### Process flow of VCIP:

- 1. An SMS containing link for booking VCIP slot will be sent to the pensioner's mobile number registered with their Pension SB account.
- 2. Pensioner to open the received link, key in their pension account number and select the desired date/time slot for VCIP.
- 3. Upon successful booking of the slot, the Pensioner will receive an SMS containing the details of the allotted time slot and a **unique link** for joining Video Call for completing VCIP.
- 4. At the time of allotted slot, pensioner has to open the **unique link** and submit the consent Form by validating it through Aadhaar based OTP to receive the video call.
- 5. Pensioner will receive the video Call by Employees' Pension Fund Section at the allotted time slot and they have to follow the instructions of the staff for Life Certificate Submission.
- 6. After successful submission of Life Certificate, the pensioner will receive a confirmation SMS for the same.

## ▶ LIFE CERTIFICATE FOR THE YEAR 2021 - PENDING STATUS:

Majority of our Ex-employee Pensioners/Family Pensioners have submitted their Life Certificate for 2021. However, as on date 1624 pensioners/family pensioners are yet to submit their Life Certificate (LC) for the year 2021 and the list of such pensioners is made available in our Bank's website under Ex-employees section. We once again request these pensioners to submit/update their LCs expeditiously.

### > REVISED PPO:

Consequent to revision in salary/emoluments as per the XI BPS / VIII JN, the revised PPOs to the eligible pensioners have been sent on their email-ids. However, it is observed that still many of the pensioners are yet to update their Email-Id. We advise such of those Pensioners who have not updated their email-id to update the same in their Pension account immediately.
