We have vide our HO Circular Nos. 375/2017 dated 28/07/2017 communicated the one month pro rata premium, as advised by the United India Insurance Company, to be paid by those Retirees / spouses of deceased employees who have retired / died during the tenure of the existing employees' Policy period of 01.10.2016 to 30.09.2017, to get themselves covered for the month of October 2017. Now we have received, revised one month pro rata premium from the Insurance Company.
