## Subject: Affirmation/Revision of Ratings

Exchanges are hereby informed that the Fitch Ratings ("the Rating Agency") has initiated/revised the rating action on Canara Bank and published the ratings on their website on 31<sup>st</sup> May 2019, as under:

## Rating Rationale by Fitch Ratings with reference to VR (Point No 3 mentioned above):

The one-notch downgrade of Canara's VR to 'bb-' from 'bb' reflects its core capital relative to risk appetite. It also reflects the bank's persistently moderate core capital position (relative to similarly or higher rated peers) which is not commensurate with its weak asset quality and earnings. The VR also factors Bank's stable funding with continued growth in its low cost deposit base. Its majority state ownership, adequate franchise and wide reach are key elements underpinning funding. Further, it is stated that the bank will need to be supplemented by equity support from the state. The Bank is however committed to not breaching minimum regulatory capital under any circumstances.
