CANARA BANK, a premier Indian Public Sector Bank (hereinafter referred as "Bank") having Pan India presence, invites Expression of Interest from leading consultants / vendors of repute and standing to assist Canara Bank in implementing Information Security Management System (ISMS) as per ISO 27001 standard & obtain Certification.

The companies submitting the proposal in response to this EOI shall hereinafter be referred to as 'Bidder'. The words "Vendor", "Consultant", "Applicant" referred in this document shall be collectively referred as "Bidder".

The interested vendors / consultants who are in the business of assisting the organizations in implementation of ISMS and obtaining of ISO 27001 Certification as above and meet the following qualifying requirements may respond.

A. SCOPE OF THE PROJECT / ROLES & RESPONSIBILITIES:

The scope of the project is to develop and implement Information Security Management System (ISMS) as per ISO 27001 framework towards obtaining ISO 27001 Certifications to the following unit:


"Department of Information Technology Wing of the Bank - including Data Centre of the Bank located at Bangalore in an environment managed by vendors of CBS application in collaboration with bank personnel and Disaster Recovery Centre located at Mumbai."

Department of Information Technology Wing of the Bank intends to adopt ISO 27001 certification standards approach for establishing, implementing, monitoring, reviewing and continually improving the Information Security Management System of the Bank.

The implementation shall include but not limited to the following:

- 1. Study, Review the existing Information Security Management System of the Bank against ISO 27001 standard.
- 2. Conduct gap analysis and identify the areas of security that are to be resolved and fortified.
- 3. Assist the Bank in establishing and implementing the new processes and systems for monitoring these standards at periodical intervals.
- Assist the Bank to assess and gather all requirements to apply for ISO 27001 certification.
- Assist the Bank in obtaining the ISO 27001 certification from a reputed, recognized certification agency.

- 6. Assist the Bank for monitoring the same under the standard and show continual improvement thereafter under Information Security Management System.
- 7. Assist the Bank in equipping itself for ISO 27001 surveillance audit after certification and recertification audit by the Authorised Auditors.
- 8. Assist the Bank to assess the training needs and impart the same on its approval by the Bank.
- 9. The vendor should employ a robust and proven framework for Information Security Management System for implementation to ensure successful completion of the project and leading to ISO 27001 certification.

OTHER CONDITIONS

- 2. Subcontracting of any work relating to the scope of EOI is not allowed except for ISO 27001 Certification Services which has to be carried out by an Authorized Certification Agency only.

Remarks:

Failure to produce the documents to prove Eligibility Criteria along with EMD/ and application fee while submission of EOI proposal shall render the bidder ineligible for empanelment.

C. SCOPE OF EMPANELMENT

- a. Empanelment would be for Information Security Management System Implementation (ISO 27001:2005) Consultants in Canara Bank.
- b. Empanelment would be for one year.
- c. During the empanelment period, Bank will float limited tenders amongst the empanelled vendors and seek responses for various requirements. Individual tender/s will contain detailed terms and conditions, instructions and scope of work.

- d. If the service provided by the consultant is found to be unsatisfactory or if at any time it is found that the information provided for empanelment or for any tender is false or if irregularities shown by the vendor when applying for the tenders, the Bank reserves the right to remove such consultants from the empanelled list without giving any notice to the vendor in advance.
- e. Bank reserves the right to cancel the empanelment of any consultant for any reason deemed fit by the Bank. Bank's decision will be final in this regard.
- f. The guidelines issued by Ministry of Finance, Central Vigilance Commission and any other statutory / regulatory body related to selection, appointment and employment of Consultants from time to time, shall be applicable.

D. EMPANELMENT PROCEDURE

The Bidder will be empanelled as consultant as per the following process:

- a. The bidder satisfying the eligibility criteria will be empanelled after due scrutiny of documents submitted by the bidder, subject to the following:
 - All the shortlisted intending bidders have to make a presentation before the panel of bank officials. The date of presentation shall be intimated to the shortlisted bidders in advance.
 - ➤ Based on the documents submitted, presentation made and the marks secured by the bidders as per the scoring matrix furnished in the Annexure G, the bidders will be ranked. All those bidders who satisfy the eligibility criteria and secure total marks of 55 and above shall be empanelled.

E. CONFLICT OF INTEREST

- 1. The consultant shall not receive any remuneration in connection with the assignment except as provided in the contract. The consultant and its affiliates shall not engage in consulting or other activities that conflict with the interest of the employer under the contract.
- 2. The ISMS Consultant and any of its affiliates/consortium members will not be eligible to work in any of the projects as IT implementation agency where the consultant has provided their consultancy services.
- 3. The consultant shall not get associated as consultant /advisor/ implementation agency or in any other capacity with any of the agencies taking part in the bid process in the project in which the consultant is appointed as consultant.

4. Participation by ISMS consultant with a conflict interest situation will result in the disqualification.

F. INSTRUCTIONS TO THE APPLICANTS

- 1. The response should be submitted in a structured format as per the checklist appended and it should be paginated. Each page of the application should be signed by person/s on behalf of the organization having necessary authorisation / PA to do so, duly affixing the company seal. Applications containing false or inadequate information are liable for rejection. (Copy of Power of Attorney or Authorization Letter from the company should be furnished along with the Bid)
- 2. Any alterations, erasures, overwriting, blanking out or discrepancies in figures etc will have to be necessarily authenticated by the authorized signatory.
- 3.
