

LCR – Disclosure September 2017

The liquidity coverage ratio (LCR) is to promote the short term resilience of the liquidity risk profile of the banks. With effect from 1st January 2017 the minimum LCR requirement is 80% (for the calendar year) which will be stepped up annually by 10% to reach 100% by 1st January 2019.

LCR basically ensures that the Bank maintains an adequate stock of unencumbered highquality liquid assets (HQLA) that can be converted easily and immediately into cash to meet liquidity needs for a 30 calendar day liquidity stress scenario.

The following table shows the daily average LCR maintained by the Bank for the quarter ended 30th September 2017 which covers 73 data points.
