# We wish all our Pensioners a very Happy Ganesha Festival!!!!

We are happy to inform that Pension Arrears/Net Incremental Commutation after recovering excess pension paid (where ever applicable) from the next date of retirement till date have been disbursed to all the concerned ex-employee Pensioners, consequent to revision of "PAY" as per X BPS/Joint Note dated. 25.5.2015. In this connection, we would like to inform the following:

- > Revised PPO & Arrears Calculation Sheet will be dispatched in due course.
- > The Pensioners who have not yet received Pension Arrears/Incremental Commutation may take up with us immediately.

### **INCOME TAX**

- ➤ For Income tax assessment purpose, the excess pension amount recovered from incremental commutation, if any, will be reduced from the total pension payable for FY 2015-16. No other income like Salary arrears etc. will be accounted for assessment of Income Tax by the Pension Fund. Hence, pensioners shall make their own arrangements for calculation of Tax and remittance of the same.
- Employees retiring during the FY 2015-16, shall note to assess their income tax liability by combining their salary income with arrears of salary / other taxable income along with the pension amount receivable and make their own arrangements to remit the differential tax, if any.

- > Those who are yet to submit the income tax declarations for FY 2015-16 may do so by submitting the same now, either by way of letter or through email.
- ➤ The proof of investments for IT exemptions should be submitted on or before 31.12.2015. However, the same shall be accepted up to 20.01.2016.
- ➤ Those who have submitted declaration on HL repayment/interest, provisional interest collected certificate is to be submitted and for insurance premia payable after 31.12.2015, but before 31.3.2016, a copy of the receipt paid during last financial year may be provided.

### MEDICAL INSURANCE SCHEME

- > All ex-employees may refer "IBA Medical Insurance Scheme for the retired Officers /employees", the details of which are uploaded in the Bank's website. (Ref: Circular No. 443/2015 dated. 7.9.2015 issued by IR section, HR wing, HO).
- The last date for submitting the option is 30.09.2015.
- > The retired employees may contact the HRM Section, CO wherein they are residing.

### LIFE CERTIFICATE

- ➤ Life Certificates are to be submitted at nearest branch of Canara Bank in the format attached in the Annexure I, during the month November 2015. If confirmation from the concerned branch is not received on or before 31.12.2015, the pension for the month of December 2015 payable on 1.1.2016 and also for subsequent months will be kept on hold.
- > The list of pensioners who have not submitted the Life Certificates for the year 2014 and the pension amount kept on hold is furnished in the Annexure II. Pensioners who know their whereabouts / contacts are requested to furnish the details like mobile no. etc for releasing the pension or otherwise.
