Dear Pensioners,

Ministry of Finance, GOI vide their Gazette Notification G.S.R. 155(E) dated 04.03.2020 has approved **Amalgamation of Syndicate Bank with Canara Bank with effect from 01.04.2020**. Accordingly, the necessary steps for unification of Canara Bank Employees Pension Fund with the counterpart in Syndicate Bank are being taken for smooth transition of amalgamation process. In this regard, it is our endeavor to ensure that no inconvenience is caused to the pensioners of both the entities. It is our pleasure to serve 70000+ pensioners of the combined entity w.e.f 01.04.2020 and post amalgamation, no pensioner need to have any apprehension on the services being extended.

### **INFORMATION ON INCOME TAX FOR FY 2020-21 (AY 2021-22)**

- In Budget 2020, the Income tax department has introduced the concept of new tax regime by way of insertion of new section 115BAC. From 2020-21 FY (2021-22 AY) onwards, individuals will have an option to choose between the new and old tax regime. Both regimes have separate tax slabs and rates along with separate deductions/exemptions. This scheme provides an option to the tax-payers to pay tax at reduced rates subject to fulfillment of certain conditions.

- If tax payers opt for existing(old) regime, the tax slabs remain unchanged as compared to previous year. The Income tax slabs for FY 2020-21 under existing (old) regime are as follows:

- 4% Health & Education Cess on Income Tax and full rebate under 87A if total income is within ₹ 5 Lakhs for individuals is present under both existing and new regime.
- All deductions under chapter VI-A (like section 80C, 80CCC, 80CCD, 80D, 80DD, 80DDB, 80E, 80EE, 80EEA, 80EEB, 80G, 80GG, 80GGA, 80GGC, 80IA, 80-IAB, 80-IAC, 80-IB, 80-IBA, etc) will NOT be claimable by those opting for the new tax regime.

### OTHER INFORMATION ON INCOME TAX MATTERS

- Our Fund has advanced the pension crediting date from "first working day of following month" to "last working day of the respective month" from October 2019 onwards for the benefit of the pensioners. Even if there is any holiday on the pension crediting day, pensioners will not be affected since the disbursement date will be advanced to the previous working day in such scenarios.
- Due to the above pensioner friendly initiative by the Fund, there will be 13 pension credits for FY 2019-20. Hence, the taxable income for this year will be a total of 13 months pension (Pension of March 2019 credited on April 2019 which was not taxed during previous year will be included with the 12 months pension of the current year). This is applicable ONLY for the current financial year. Provision for this is already made by us while calculating Income Tax for this FY. Hence, the gross income in Form 16 Part B for FY 2019-20 will reflect pension amount of 13 months. Pensioners are advised to take note of the same.

- As per CBDT notification dated 12.04.2019, tax deductors must generate Form 16 only from TRACES as per the notified format. Hence physical format of Form 16 provided by the Pension Fund has been dispensed with. Pensioners must download the digitally signed Form 16 only from our Bank's website when made available. (Pensioner will be able to download only Part B of Form 16, if no tax is deducted for them)
- Pensioners are requested to submit their investment declaration in the month of April itself for the financial year 2020-21 only if their total taxable income from pension exceeds the exemption limit and have opted to pay tax under the existing (old) scheme. Further modalities regarding opting of the tax regimes by the pensioner will be issued shortly.

### LIFE CERTIFICATES - PENDING FOR SUBMISSION FOR THE YEAR2019

- There are 200 Regular, Family and Ex-gratia pensioners who are yet to submit their Life Certificate due in the month of November 2019. We have stopped disbursement of monthly pension to them from January 2020 onwards. The list of Pensioners for whom Life Certificates are yet to submitted as on 06.03.2020 is furnished as a separate attachment. Those who find their name in the list are advised to take up with the nearest Branch for uploading the Life certificate in HRMS package or to submit through Jeevan Pramaan.
- Pensioners who have any information on the personnel whose name appears in the list are requested to furnish their contact numbers for updating our records and release their pension.
