Man found murdered in Proddatur of Kadapa district

A middle-aged man Koppula Raghavendra was found murdered at a private lodge in Proddatur town of Kadapa district on Monday. He had taken the room at the lodge located in Sundarachary Street on Sunday night and consumed alcohol with his friends. It is believed that the friends started quarreling which escalated into a physical fight, in which Mr. Raghavendra's head was smashed with a beer bottle by one of his friends, leading to his instantaneous death. Police records point to Mr. Raghavendra's criminal background, as he had several cases registered against him across police stations. A case has been registered.

Two killed in road accident in Kadapa district

Two persons were killed and four others were injured in an accident involving a private bus and an autorickshaw, at Porumamilla in Kadapa district on Monday. Subbiah Achari and Rosaiah, residents of Akkalreddipalli, died when the autorickshaw in which they were travelling was hit by a speeding bus. Police shifted the bodies from the hospital for post-mortem and have registered a case. Meanwhile, the four injured persons are undergoing treatment at the local government hospital.

'12-year-old land disputes of 8 farmers solved through PGRS'

District Collector Rajakumari Gania expresses dissatisfaction over certain officials' negligence in resolving the complaints and points out allegations of corruption against Village Revenue Officers

The Nandyal district administration finally resolved the land disputes of eight farmers who have been making rounds of government offices for over 12 years. The farmers had petitioned to the district administration through the Public Grievance Redressal System (PGRS), and necessary orders clearing the land from dispute were issued on Monday.

District Collector Rajakumari Gania said that the administration sought records from the ground level after the farmers' petitions and officials were asked to denotify the lands

belonging to these farmers from the prohibited lands list. The lands belong to farmers from Allagadda, Mahanandi, and Sirivella mandals.

**Officials' neglect**  
Addressing the officials during a review of the redressal of grievances peti-

tioned through the PGRS, Ms. Gania expressed dissatisfaction over certain officials' negligence in resolving the complaints. "Some officials at the mandal and district level are negligent in resolving the petitions even as the PGRS is being monitored by the Chief Minister's Of-

fice (CMO) directly. Some officials are endorsing the petitions without placing serious effort to resolve them," she observed, while highlighting that grievances that were forwarded from the CMO were also kept pending. There were allegations of Village Revenue Officers (VROs), who play a key role in the Revenue Department, indulging in corrupt practices, she said. "Stringent action will be taken against those who face allegations of corruption," she warned. She asked officials to ensure that the petitioners are not compelled to make rounds around government offices by resolving their grievances within the specified time.
