CanaraBank, Tirupati Circle Office invites applications from empanelment of experienced and authorized security equipment firms dealing in procurement, installations and AMC of Security Equipments (such as CCTV, Security Alarm, Fire Alarm, Fire Extinguishers etc) for various branches, ATMs, Admin Offices, Currency Chests etc under the jurisdiction of Canara Bank Circle Office Tirupati. Circle Office Tirupati has 06 Regional Offices situated at Tirupati, Anathapur, Kadapa, Kurnool, Nellore and Ongole. Circle Office Tirupati and its 06 Regional Offices' Area of Responsibility(AOR) comprises of atleast 345 locations spread across the 10 districts of Andhra Pradesh which are Tirupati, Chittoor, Kurnool, Nandyal, Ananthapuram, Sri Satya Sai, YSR Kadapa, Annamaiah, Sri Potti Sriramulu Nellore & Prakasam districts. Approximate number of locations per RO/District is attaches as per **Annexure 'A'** 

The Applications are invited in the form of 2bid-system. This comprises of submitting 02 separate sealed quotations holding 2 bids i.e., Technical bid and financial bid. Technical bid shall be evaluated as per eligibility criteria and Financial bid would be indicative for standardization of rates for Supply, Installation of new equipments, parts replacements & AMC of existing equipments.

#### **GENERAL TERMS & CONDITIONS**

I. **PERIOD & CATEGORIES OF EMPANELEMENT**: Empanelment of Security Vendors for Supply, Installation & AMC of Security & Fire Safety Equipments for Branches, ATMs, Currency Chests, and Administrative Offices etc under CO Tirupati for a period of 1 years, extendable up to 2 years subject to performance review, annually.

The details of Empanelment Category / Item or System / Equipments are as under.

## i) Category -Empanelment shall be for Supply, installation as well as AMC support of:

- a) All 04 equipments (CCTV, Security Alarm, Fire Alarm & Fire Extinguishers)
- b) 03 equipments (CCTV, Security & Fire Alarm) only
- c) Fire Extinguishers only.

No bid / offer for support of individual solutions or more which is not covering the above three combinations will be entertained.

#### ii) Category - Annual Maintenance Contract

- a) On new existing CCTV, Security & Fire Alarm Systems installations (where OEM warranty is still applicable) quarterly health checks needs to be done till the time warranty on DVR/NVR/ Alarm Panels is expired. Post warranty AMC shall initiate as per agreed terms & Conditions of this empanelment.
- b) For new installations during the currency of this empanelment, 02 years warranty is desired along with 08 mandatory health check visits. Post warranty, AMC shall initiate as per agreed terms & Conditions of this empanelment.
- c) Non Comprehensive AMC on the existing CCTV, Security & Fire Alarm Systems in all allotted locations once every quarter.
- d) Refill & AMC in case of fire extinguishers
- e) Warranty on the equipment offered by Original Equipment Manufacturer (OEM), if more than 02 years on certain components like HDD, DVR/NVR, Alarm Panels etc., is desired to be extended to the Bank.

#### II. AIM OF EMPANELMENT:

a. To create and have pool of readily available Sec Vendors capable of supplying the required system, equipment / components, or services as per the laid down specifications, at competitive rate without loss of time and are also able to provide after sales service for at least 03 years to ensure all time serviceability thereby prolonging the life of the security equipment, in our Circle Office. Bank intends to have 3 to 6 (or more) Security & Fire Safety Vendors for the AOR under Circle Office Tirupati. Once empanelled the vendor maybe allocated work based on Bank requirement, but vendor shall remain on the Bank's empanelled list.

b. Vendors applying for CCTV, Fire Alarm and Burglar Alarm have to apply for all three equipments as per Para I.(i).a to Para I.(i).c together. Applying for only one/two of the items will not be considered.

c. Vendors applying for Fire Extinguishers are to apply separately.

- III. **AUTHORITY:** The empanelment shall be finalized at Circle level.
- IV. The evaluation of Bids and finalization will be based on documents submitted by the bidders for Circle and site visits.
- V. All documents attached with this RFP i.e from pages 2 to 71 only, including the specifications and any addendum/amendments issued before the submission date are SACROSANCT for considering any offer as complete offer. All addendum/amendments in respect of this tender if any will be displayed on bank's website only and no paper advertisement will be released. All interested vendors are advised to monitor the bank website for any addendum/amendments.
- VI. The Offer must be submitted along with all relevant documentation as specified in Sl No XVII.1 along with RFP Acceptance letter as in Annexure 'B', methodology of support offered by the company to meet the our terms & conditions, change management, staffing plan, repairing facilities, repairing mechanism, maintenance strategy, support mechanism, Business Continuity Plan and all documents showcasing the health and eligibility of the company as specified in Annexure 'C', 'D', 'E', 'F', & 'G'. - VII. a. Incomplete offers, offers not conforming fully to RFP requirements or with vague replies will not be considered.
  - b. Any conditional bids/applications shall not be considered and will be out rightly rejected in the very first instance.
  - c. Bank will not entertain any claim from any bidders at any stage regarding any rejection as specified above
  - d. The Bank reserves the right to accept or reject any or all the applications without assigning any reasons thereof and their decision of selection will be final.

VIII. **Definitions:** The definitions in the RFP to be understood subject to exceptions.

a.	Sec Vendor	The word Sec Vendor means any original manufacturer / authorized Supplier or Dealer or AMC provider of any of the Security & Fire Safety equipment, who will be submitting their offer /bid to act as the System Integrator regarding Security Equipments as specified in the RFP.
b.	Equipme nt / Security Equipme nts	The word equipment means any System/Gadget/Components used for installing in the branches / offices etc for the purpose of Security, surveillance & Fire Safety etc., related to the security gadgets specified in Para I Category (i) & (ii) or similar solution being offered in the bid.
c.	Items:	The items shall be the equipments shown in Para I Category (i) & (ii) including its sub-categories & individual components, unless specified different.
d.	NPC	Notarized Photocopy – All copies of the documents, where ever specified as 'NPC' shall be a notarized photocopy which is not more than 3 months old from the date of release of the RFP

#### IX. EARNEST MONEY DEPOSIT (EMD)

- a. The bidder shall have to deposit earnest money in the form of Bank Guarantee to get empanelled. It should be valid for one year from the last date of proposalsubmission,
  - i) Rs. 50,000/- (Rupees Fifty Thousand Rupees Only), the Sec Vendor dealing with CCTV, Security & Fire Alarms
  - ii) Rs 25,000/- (Rupees Twenty Five Thousand Only) for Sec Vendors dealing with Fire Extinguishers.
- b. The period of the EMD can be further extended as per the Bank's requirements with reference to RFP processing. The offer without Earnest Money Deposit, as specified above (Para IX.a) would be considered as non-responsive, incomplete and shall be out rightly rejected.
- c. The EMD shall be released/ returned to all the bidders except successful bidders after finalization of Empanelment process. In case of successful bidders the EMD shall be released after receipt of requisite Performance Guarantee (PG). In case of un-successful bidders, EMD shall be returned to any representative from the firm on production of authority letter & Receipt in Company Letter Head, Authorized by Signatory Specified in the Bid Document. Proper receipt in letter head signed by the Authorized Signatory & specifying the authorization letter shall be enclosed with such authorization letter.
- d. The EMD submitted to the Bank may be invoked and amount forfeited in case the bidder backs out from the offers made by it under empanelment process after being declared as successful Sec Vendor.
- e. If any firm is exempted by the Govt Authorities with regard to registration with NSIC/ MSME etc, **notarized photo copy** of these sanctions issued by such authority in the name of the firm shall be enclosed. In case any financial limit is specified in the sanction, the Firm shall submit an undertaking that the sanction is still valid as the limit is not exhausted.
- f. Submission of NPC as specified in Para IX. e above shall apply for the case of RFP Cost exemption also.

#### X. PRE-QUALIFICATION CRITERIA (PQC)

- a. Qualification criteria given below specify minimum Qualification criteria in various areas to ensure that **Sec Vendor** has necessary experience, expertise, financial strength and skilled human resource to provide quality service to the Bank.
- b. Documents are not transferable.
- c. Provide documentary details wherever necessary.

# d. Following are the mandatory requirements (Submission of documents/proof shall be as per Technical Bid under Para XVII.1)

- 1. Should be financially strong to undertake such kind of projects and should furnish the documents like audited balance sheet of last 3 years along with P& L statements.
  - a) Should have a turnover of Minimum Rs.50 Lakhs per year on account of similar services, in last 3 years for CCTV, SECURITY
     & FIRE ALARM PANEL VENDORS
  - b) Should have a **turnover of Minimum Rs.20 Lakhs** per year on account of similar services, in last 3 years for Fire EXTINGUISHERS VENDORs.
- 2. Should have a presence in the market for offering services from the past 3 years with experience in offering similar solutions as specified in PQC Para X.d.6, Para X.d.7 & Para X.d.8 below.
- 3. Should be a registered firm with office preferably within the area of operations of Canara Bank Circle Office Tirupati. Should have Certificate of Registration with Registrar of companies (or) Registrar of Firms (or) Partnership firm with proper partnership deed or letter of Proprietorship (attested copy to be attached) and have Registration under Shops & establishment Act- issued by the Andhra Pradesh state authorities.
- 4. Should have valid GST Registration.
- 5. The bidder shall have to deposit earnest money in the form of Bank Guarantee to get empanelled as below. It should be valid for one year from the last date of proposal-submission. Vendors with Valid MSME registration are exempted.

Should submit Bank Solvency Certificate of **minimum Rs. 50 Lakhs** for Security equipment vendors and **Rs 20 Lakhs** for Fire Extinguisher Vendors, to establish the financial soundness of the Company. The Solvency Certificate shall be issued by any scheduled or commercial Bank, addressing to "The AGM, Canara Bank GENERAL ADMINISTRATION Section Circle Office Tirupati" and clearly specifying the RFP Number in the Subject Line or Matter). Solvency Certificate if not submitted as specified here would be considered as non-responsive, incomplete and shall be out rightly rejected.

- 7. Should be currently empanelled with PSBs / PSUs/Central/State/Govt. undertaking/ MNC for similar services for all three equipment (CCTV, Security & Fire Alarms) or Fire extinguishers whichever is applicable.
- 8. Should have current /valid AMC with PSBs / PSUs/Central/State Govt. undertaking/MNC for Similar Services for all three equipment (CCTV, Security & Fire Alarms) or Fire extinguishers whichever is applicable.
- 9. Should have undertaken Installation of minimum 100 Units each of all the equipments.
- 10. Should have registered office in Andhra Pradesh, preferably within the area of operations of Canara Bank Circle Office Tirupati and effective infrastructure or workshop for undertaking repair of equipments in **Andhra Pradesh**, intended for offering services.
- 11. Must be an income tax assesse and should have filed IT returns for the last three Assessment Years, with valid PAN/TAN. Should be following all statutory guidelines of Taxation.
- 12. Any original manufacturer / authorized Supplier or Dealer or AMC provider of any of the Security & Fire Safety equipment, who will be submitting their offer /bid to act as the System Integrator regarding Security Equipments as specified in the RFP.
- 13. Should be either OEM or having any OEM certification exclusively in the name of Sec Vendor, specifying maintenance support and clearly specifying the RFP Number in the Subject Line or Matter.
- 14. Pre Contract Integrity Pact as per **Annexure 'K'** to be submitted on a Non Judicial Stamp Paper of Rs 200/- along with Technical Proposal
- e. Additional qualifications, which may give weightage to the bidder in the empanelment process
  - 1. ISO or other relevant Certifications
  - 2. Any other certificate regarding quality assurance issued by a third party authorized to issue such certificates

#### XI. EMPANELMENT & AMC SERVICES TERMS & CONDITIONS

- a. The Bank reserves the right for selection and finalization of empanelment as per laid on procedures. The Sec Vendors will be considered for empanelment only if it meets all conditions specified in this RFP and screening being done by the Bank.
- b. Empanelment would be done for Supply, Installation & AMC of Security & Fire Equipments for Branches/ATMs/CCs/Administrative Offices etc under various ROs for a period of 2 years, which may be extended further for a period of two years based on review of performance.
- c. Empanelment shall be for Supply, installation as well as AMC support of :

i) All 04 equipments (CCTV, Security Alarm, Fire Alarm & Fire Extinguishers)

- ii) 03 equipments (CCTV, Security & Fire Alarm) only
- iii) Fire Extinguishers only.

No bid / offer for support of individual solutions or more which is not covering the above three combinations will be entertained.

The Indicative QRs - Technical as well as other Specification of various Items of all Categories has been shall be as specified in Annexure 'H' for reference. (These are the minimum specification required. Any equipment / solution of same or superior QRs/ solution with same or better output shall be accepted for technical scrutiny).

d. Fresh Installation of New Systems (complete with accessories) as per category (i) of Para I or similar solution

The successful Sec Vendors who are selected for empanelment will be allotted with specific branches / ATMs for providing AMC services, repairs as well as new equipment installations by the Circle Office. The allotment shall be done generally for covering all systems of a particular branch to a single Sec Vendor. However, such allotment of the work/branches will be at the sole discretion of the Bank depending upon the performance and urgency etc. During the currency of empanelment, fresh installations of complete systems in branches/ATMs would be as per indicative rates finalized during this empanelment by the allotted vendor after approvals from CO. However incase new branches are opened s per RBI, bank may go for quotations process amongst the empaneled vendors for those sites.

Installation of each item shall be completed within the time period specified in the order, which will be intimated to the Sec Vendor through registered email id or any other official means. In case of delay, due to any genuine cause, Sec Vendor may submit representation to RO within 4 days of issue of the order for approval. RO reserves the right to accept the representation or not based on merit.

If the installation of items are not completed within stipulated time, clauses specified in "penalty" as well as "liquidated damages" of the RFP shall be imposed.

e. AMC of items of Category (i) of Para I, as per category (ii) of Para I

After successful empanelment of Sec Vendors, Branches/Offices/ATMs under various ROs will be distributed amongst the empanelled Sec Vendors as per L1, L2, L3...etc at the sole **discretions of CO.** The Sec Vendor shall take over AMC/Health Check on newly installed Systems whichever is applicable. For spares, which are not covered under warranty, the payment for the same shall be done based on finalized rates.

General aspects (AMC)

- f. Site response time: The AMC Sec Vendor shall turn up for attending the problem within a time period of 24/48 hours (48 hours for outstation) from the time of registering of the complaint, failing which may attract penalty. This would not include bank holidays.
- g. <u>Turn-around time:</u> The AMC Sec Vendor shall repair / replace/ provide solution within a time period of 48 / 72 (72 hours for outstation) hours from the time of

registering of the complaint. This would not include bank holidays. In case the equipment could not be brought into working conditions within the time specified above, the Sec Vendor shall provide a substitute so that the working of the system should continue, failing which may attract penalty.

- h. **Preventive Maintenance visit by Sec Vendor**: Mandatory visit once in a quarter (even if the branch has not called):- At least one mandatory preventive Maintenance visit shall be arranged by AMC provider once in each quarter even if there is no Complaint from the branch. Details of the visit shall be recorded in the Equipment Register and a copy in detail shall be forwarded to RO.
- i. **Procedure for 'On Call Visits'**: whenever required by branches to attend any complaint or repairs: -
  - The branch will be making the lodging complaints on telephone number of the AMC provider or by email.
  - While registering the complaint, a complaint number shall be generated, by service provider, with date and time and inform branch as well as GA & Security Cell RO.
  - Likely time of deputing the technician shall be informed to the branch by the Sec Vendor.
  - The branch shall make note of the complaint number (With date and time) in the security equipment checking register.
  - When the technician from the AMC provider visits the branch / repairs the system, he shall make entry against the complaint in the register with details of the defects, its rectification as well as present status.
  - The Officer in charge of the branch shall endorse his remarks against rectification of each and every complaint.
  - Maintenance / Repair log for each equipment shall be recorded and shall be kept updated in the register.
  - Branch officials to ensure that the system is working fine before giving the sign off.
- j. <u>Service Report:</u> The repairs shall be carried out at the branch itself (on site). In case the equipment is required to be taken to the workshop for repairs, the replacement / stand by system shall be provided by the AMC provider. Service report shall be duly completed after the closure of the complaint which shall be signed by the technician and officer in charge.
  - First copy shall be handed over to the Branch.
  - Second copy shall be sent to RO GA Section by the Sec Vendor.
  - Third copy may be retained by the AMC provider as record.
  - Consolidated summary of branch visits shall be sent once in a quarter to RO GA Section; eg first week of July, October, January and April. This shall include details of both "Preventive Maintenance visits" as well as "On call visits".

#### Additional Scope and Coverage of the AMC:

k. Repairs: All services and repairs on the existing systems shall be carried out by the SecVendor as part of AMC and payment on replaced items shall be as per approved rate chart. No extra cost will be paid, other than AMC rates. Every time the technician visits, he shall clean, check, service and repair all components for its serviceability, free of cost. No replacements of equipments shall be approved without proper technical justifications. In case the DVR/NVR/BA Panel/FA Panel needs to be sent for repairs to the SecVendor repair facility

location or OEM Repair facility location, a standby system to be provided by the SecVendor to reduce the outage.

- New Installation: In case of the complete replacements of any of the systems (CCTV/Security & Fire Alarm Systems), irrespective of reasons and through any of the suppliers during the currency of the AMC, the AMC of the old / unserviceable system will be ceased and warranty conditions with quarterly health checks under nominal rates and complaint visits on the new system shall begin. Only AMC Charges for the remaining Systems of that branch shall be paid. In case of partial replacements/additions of components & accessories (other than DVR/NVR in CCTV systems & Panels in Alarm Systems) on the existing systems which are categorized as under AMC, the system's AMC will continue. Payment of those particular replaced items would be as per the agreed and approved rates in the contract.
- m. Items under warranty: Dates of installations of equipments under OEM warranty prior to this empanelment shall be shared with the Selected SecVendors of that region. In case of recent full system installations before the commencement of this empanelment, which are already under OEM warranty shall be desired to be visited quarterly for health checks under nominal rates till the end of warranty on the DVR/NVR/BA & FA Panels of these systems.

#### General:

a.The scope of work involves supply, installation and maintenance support of security equipments as specified in this RFP for Branches / ATMs / Admin Offices etc of Canara Bank across the area of operations under Circle Office Tirupati, Andhra Pradesh. Mere empanelment of vendors should in no way be construed as work order of any nature.

- b. Bank reserves the right to go for additional empanelment through advertised mechanism, if required, due to any reason what so ever, even after completion of this empanelment process or during currency of this empanelment. And Bank may also change procedures of procurement/services as per the changes in the Bank procurement policy.
- c. On event of finalization of any new item (not listed in the price bid) as a part of any Category / equipment during the currency of the empanelment, the L1 rates of the same will be finalized at CO as per procedure in place. Sec Vendor shall ensure installation of the same within 21 days/as agreed with the RO/CO in all Branches / ATMs etc. No deviation in this shall be accepted. If any deviation found after completion of a quarter, penalty clause shall be invoked.
- a. Bidder shall keep the offer open for a minimum period of 180 days from the date of opening of the Bids within which period the Bidder cannot withdraw their offer including the period being extended further, if so required, by mutual agreement from time to time. Any contravention of the above conditions will make the Sec Vendor liable for forfeiture of their Earnest Money Deposit.
- b. Bank reserves the right to go for additional empanelment through advertised mechanism, if required, due to any reason what so ever, even after completion of this empanelment process or during currency of this empanelment.

c. The SecVendor who is undertaking the AMC and the SecVendor who had supplied / installed CCTV system during warranty, shall have the system of

HDD cloning or shall get the HDD cloned, without loss of any data, so that on requirement, entire HDD can be duplicated for investigation within a short time span.

#### XII. OTHER CONDITIONS

- a. All entries in the Offer form should be legible and filled clearly.


