The successful bidder should Submit a Security Deposit for Rs. 30,000/- within fifteen days from the date of acceptance of the tender for due performance of the Contract. The Security Deposit shall be by way of Performance Bank Guarantee/DD issued by a Scheduled Bank in India other than Canara Bank. The Performance Bank Guarantee should be valid for 12 months from the date of commencement of contract. The guarantee should also contain a claim period of three months from the last date of validity. The Performance bank guarantee will be returned to the bidderwithin15 days after completion of Contract period subject to satisfactory performance and on the contractor rendering a No Demand and No Due Certificate, and after adjusting any sums due to Canara Bank from the contractor. The Banks hall invoke the Performance Bank guarantee before the expiry of validity, if the successful bidder breaches the contractor fails to complete his obligations under the contract. The bank shall notify the bidder in writing before invoking the bank guarantee. The proceeds of the Performance Bank guarantee shall be payable to the Bank.

ANNEXURE 1

SCOPE OF WORK & ELIGIBILITY CRITERIA

ELECTRICAL SERVICES (INCLUDING MAINTENANCE OF SUBSTATION AND OTHER RELATED HT/LT EQUIPMENTS)

- 1. Contractor should provide qualified electrician (minimum ITI passed).
- 2. Electrician should have knowledge of both HT and LT.
- 3. Two electricians should be available during the day shift and one electrician during the night shift on all days including holidays & Sundays. On requirement, tenderer would have to deploy the entire electrician staff simultaneously.
- 4. Internal Daily Work: Daily switching OFF & ON of the mains in the ground, first & second floors of the main block, passages, street lights, sign board lights, hostel block, canteen block to be ensured by the electricians.
 - i) For lectures, meetings & conferences, the electricians should arrange and operate equipment's like mike system, lightings, A\Cs as per the instruction of College Administration.
 - ii) Preventive maintenance/cleaning of all electrical equipment's including fans, geysers, coolers etc. to be carried out at regular intervals.
 - iii) Uninterrupted power supply to the campus to be ensured. Operation of generators to be taken care of by the electricians throughout day & night.
 - iv) Daily Switching off /on of the fountain motors.
 - v) Daily Switching off /on of the Glow Sign Board.
 - vi) Daily Switching off /on of the CENTRALIZED AC IN SUMMER SEASON.
 - vii) Daily Switching off /on of the HEATER / GRYSER IN WINTER SEASON
 - viii) Daily Switching off /on of the Street lights
 - ix) Cleaning of the lights, Wall fans and Ceiling Fans of hosteland also Street Lights and Glow sign boards.
 - x) Daily filing of the overhead water tank and underground tank.
 - xi) Preventive maintenance of the geyser and heater should be done before the beginning of the winter season.

Routine Work:

- xii) Electricians should be trained in UPS systems also so as to attend to minor works.
- xiii) In case of pump/motor failures, the electricians should attend to the repairs. They should be well versed with the generator systems, fire hydrant systems, fountain and sewerage pumps.
- xiv) They should also be trained in the fire fighting and operation of fire extinguishers.
- xv) Water pump & sewerage pump to be maintained and operated at regular intervals.
- xvi) The electrical supervisor should be able to monitor electricity meter readings and verify the correctness of monthly electricity bills.

- xvii) The electricians posted should also bring diesel from service station at required intervals (at Bank's cost).
- xviii)The contractor should take care of Electrical operation of AC Plant & AHU.
- xix) Regular cleaning of the Substation panel/busbar/Internal wiring through blower and with applicable tools.
- xx) The contractor should have liaison with the electricity department.
- xxi) It would be the entire responsibility of the contractor in respect of observing all Rules and Regulations (latest amendments(s)) as per various. Laws prevailing in the country in engagement/recruitment/deployment of the persons for the aforesaid jobs i.e. engaging minors, payment of their dues correctly and promptly, payment of Minimum wages as prescribed etc. The contractor should maintain salary register for all the employees engaged by them for the work and the same should be produced by them to bank officials on demand.
- xxii) Bank will not be responsible for the persons so deployed and for all the purposes they shall be treated as being on the rolls of the contractor/service provider. The persons so provided by the contractor/service provider shall have no right to any employment in this office or any other government office based on the services rendered by them or on any other basis.
- xxiii)The contractor/service provider is also liable to pay an amount equivalent to as decided by the department towards damages caused to the premises &/or to any of the equipment, furniture & fixtures, fittings etc of the COE COMPLEX by the persons as deployed by the contractor/service provider, and also reserves the right to deduct the same from arrears payable to the contractors.
- xxiv) For ensuring the same the contractor has to maintain a log book at site and the same is subject to checking by the Bank Officials.
- xxv) To attend to any other works as required by College Administration.

ANNEXURE 2

GENERAL RULES AND INSTRUCTIONS TO TENDERER

- 1. No alterations or additions are to be made by the Contractors to the tender document. Violation of this instruction will attract rejection of the tender at the discretion of the Bank.
- 2. The Bank's decision in the selection process is final and Bank will neither entertainany correspondence in this regard nor will be bound to furnish any explanation. The acceptance of an offer will rest with the Bank which does not bind itself to accept the lowest offer and reserves to itself the authority to reject any or all of the offers received without assigning any reason.
- 3. Offers which are incomplete in any respect are liable to be rejected.
- 4. Canvassing in connection with tenders is strictly prohibited and the offers submitted by the applicants who resort to canvassing will be liable for rejection.
- 5. The applicant shall furnish the list of his relatives working in the Canara Bank/list of retired Canara Bank employees employed with him.
- 6. The Tenderer or their authorized representative is requested to be present during the opening of the bids. This is optional. Bank will proceed with opening of the technical bids on the stipulated date & time unless otherwise modified.
- 7. It will be obligatory on the part of the Tenderer to tender and sign the offer documents for all the component parts.
- 8. The successful Tenderer shall execute the agreement (Annexure 6) on a stamp paper of appropriate value within 14 days from the date of acceptance of the offer, and until a formal agreement on stamp paper is prepared and signed, this offer document along with the correspondence shall constitute a binding contract between the tenderer and the Bank.
- 9. Conditional offers shall be rejected.
- 10. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, or site visits will be reimbursed by the Bank.

- 11. Documentary proof with respect to the Eligibility criteria shall be furnished along with the application form. In this regard, copies of the work orders and certificates obtained from clients and or such other documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard. Theauthorized person of the firm/ company shall sign in all the pages of the application with seal of the firm/ company.
- 12. Applications received after the due date and time is liable for rejection.
- 13. If any of the labour employed by the contractor is found to be underperforming or any misbehavior is found/reported while on duty, Bank reserves the right to ask for a suitable substitute.
- 14. Tender shall be quoted on prescribed Form only and quoting inany other form will be rejected. All rates shall be quoted on the proper form of the tender alone.
- 15. If any tendererwithdraws his tenderbeforethesaidperiod (90days)ormakes any modifications in the terms and conditions of the tender which are not acceptable to the Bank, then the Bank shall, without prejudice to any other remedy, be at liberty to forfeit full value of the EMD as aforesaid.
- 16. All entries in tender documents should be in one ink. All cancellation and insertion should be duly signed by tenderer concerned with proper indication of the name designation and address of the person signing.
- 17. The rate should be quoted in figures as well as in words in Indian Currency only.
- 18. In case the rate quoted in figures differs from those quoted in words, the rates quoted in words will be taken as the tendered rate and shall be binding on the tenderer.
- 19. The tenderer shall note that the rate quoted shall be exclusive of all taxes and inclusive of expenses of all types of Work force/ Manpower (by following Labour Laws scrupulously as per government guidelines) and expenses pertaining to the consumables, operating profit etc., and no claim for enhancement of quoted rates on any account shall be considered.
- 20. In addition to Earnest Money Deposit the successful bidder should submit a Security Deposit for Rs.30,000.00 within fifteen daysfromthe date of acceptance of the tender for due performance of the Contract. The Security Deposit shall be by way of Performance Bank Guarantee/DD issued by a Scheduled Bank in India other than Canara Bank. ThePerformanceBankGuaranteeshouldbevalidfor36 months from the date of commencement of contract. The guarantee should also contain a claim periodof three months from the last date of validity. The Performance bank guarantee will bereturnedtothebidderwithin15 days after completion of Contract period subject to satisfactory performance and on the

- contractor rendering a No Demand and No Due Certificate, and after adjusting any sums due to Canara Bank from the contractor. No interest shall be paid on the ISD(Initial Security Deposit)
- 21. The offer will be valid for a period of 90 days from the date of opening of tender.
- 22. If any tenderer withdraws his tender before the said period(90 days) or makes any modifications in the terms and conditions of the tender which are not acceptable to the Bank, then the EMD submitted shall be forfeited.
- 23. Tenderer has to arrange for inspection if required and should have carried out the works satisfactorily at the site failing of which the tender will be disqualified.
- 24. All the parts of these tender documents i.e., Tender Notice, General rules and Instructions to tenderers, Priced bill of Quantity, offer letter, General conditions of contract, and all other parts shall form a part of the contract document.
- 25. Contractor should observe utmost economy in use of electricity and water.
- 26. The daily scope of works shall be approved by the bank and the same shall be strictly complied.
- 27. The contract is valid for 12 months and performance will be reviewed in every quarter by the bank. The contract is subject to annual renewal as per discretion of Bank thereafter. In case of unsatisfactory performance during the review period, the Bank shall terminate the contract at any point of time without prior notice.
- 28. The price quoted by the Tenderer will be applicable for 1 years or the contract period. Bank may at its sole discretion enhance/decrease the price depending on annual inflation rates on consumables and minimum wages payable by consultation with the Contractor at the end of first year.
- 29. Theratetobequotedbythetenderershallbefirmandshallcoverandinclude wages to the labourers, supervisors, equipment's deployed contractorsprofit, transportation charges and all statutory levies, taxes such as "Octroi, sales tax, GST, excise duty, PF, ESI but excluding Service Tax arising from Act passed by Parliament or State Legislature and rules framed there-under. The rates shall be quoted on the formats per Part-II.
- 30. The tenderer shall note that no claim for enhancement of rates, on the ground that cost of materials, labour has increased, existing statutory levies have been increased, after tender, or in any other ground, will be entertained on any account.

- 31. Beforetendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other prevailing conditions. The tenderer should specifically note that it is tenderers responsibility to provide all items which are not specifically mentioned in the scope of works, but which are necessary to complete the subject services.
- 32. No employee of Canara Bank shall be engaged by the contractor during thecourse of carrying out the works.
- 33. The selected contractor shall at his own cost, have to comply with the rules of Haryana Labour Enforcement office and other statutory bodies presently in force and in future till the contract period. The proof of compliance need to be submitted to the Bank within one month from the date of taking over.
- 34. The contractor needs to employ his own staff for the purposes of Electrical Maintenance Services and such employment should conform to the labour act presently in force and in future till the contract period.
- 35. The successful tenderer should keep the entire internal and external premises neat and clean and should bear the expenses of cleaning materials required for the same.
- 36. All the records pertaining to Electrical Maintenance Services shall be maintained upto date and shall be made accessible to the Bank.
- 37. The payment of Electrical Maintenance Services shall be made on monthly basis against bills certified by the respective wings/sections.
- 38. The Contractor should maintain a register to record the daily attendance of Electricians and same should be produced along with the bills.
- 39. The Contractor should ensure a proper background check of all the workers employed by him and should inform the Bank as and when changes happen. Credentials of all workers are to be ensured to the satisfaction of the Bank and records of credential verification are to be submitted to the Bank.
- 40. Canara Bank shall have the right to with hold payment of, or make recoveries from claimsduetothecontractorinrespectofanylossordamagecausedoroccasioned inrespectofthepropertiesofCanaraBankunderthetermsandconditionsofthiscontract oranypaymentnecessitatedduetotheinfringementofanystatutory obligations by the contractor.
- 41. The contractor shall not transfer or sub let the work to any one without the prior written approval of Canara Bank.

- 42. Thecontractororhisauthorized representatives hall be in attendance in Canara Bank premises during all working hours for supervising thework. For any negligence of the service employed by the contractor or for anyloss or damage caused or occasioned by himself, hisagentsorwork meninrespect of the property of Canara Bank, the contractor shall be personally responsible and shall make good the loss for thwith.
- 43. Allactivitiesofworkdoneshallbeenteredinaregisterdailysothatcomplete record is obtained to fall work performed under this arrangement, and signed and dated by both parties viz., persons authorized for and on behalfof Canara Bank and the contractor each day on completion of work.
- 44. Without prejudice to any rights or remedies under this agreement if the contractor dies, the Canara Bank authorities shall have the right to terminate this agreement without any liability whatsoever as regards execution of the work for the balance contract period after the death of the contractor.
- 45. **Social Media Policy:** No person of the bank or the contractors and third parties shall violate the social media policy of the bank.

The following acts on the part of personnel of the bank or the contractors and third parties shall be construed as violation of social media policy:

- i) Non-adherence to the standards/guidelines in relation to social media policy issued by the Bank from time to time.
- ii) Any omission or commission which exposes the Bank to actual or potential monetary loss or otherwise, reputation loss on account of non adherence of social media related systems and procedures."
- 46. In case the final successful tenderer withdraws his tender, the Bank shall be entitled in its right to proceed with next successful tenderer or cancel the tender as deemed fit.

ANNEXURE 3

GENERAL CONDITIONS OF CONTRACT

1.0 The Contractor's main responsibilities will be Electrical Maintenance of the LT and HT systems of the entire internal and external premises, labour, compliance of statutory requirements and providing efficient service, etc.

2.0 DEFINITIONS/ INTERPRETATIONS

In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them -

- a) The 'Contract' means the documents forming the tender and acceptance thereof and the agreement duly executed between the Employer and the Tenderer, together with the documents referred to therein including those conditions, the specifications, schedule of quantities, tender agreement and instructions issued from time to time by the Officer-in-Charge. All these documents taken together shall be deemed to form one contract and shall be complementary to one another.
- b) The 'Tenderer' or 'Supplier' or 'Contractor' or 'Proprietor' shall mean the individual Karta, or Manager of HUF, firm or Company, whether incorporated or not, undertaking the works and shall include the legal heirs/ representatives of such individual or the partners of firm and their legal heirs and successors, or company's authorized and constituted attorneys/ agents and permitted assignees of such firm or company.
- c) The 'Employer' or 'Bank' means any officer of the Canara Bank, who is specifically authorized to enter into contracts in respect of the above works.
- d) Officer in charge: The designated employee of the Bank, assigned with powers to enter into contract.
- e) 'Contract Price' shall mean the final accepted rates in Price Bid hereto.
- f) 'Date of Contract' means the Calendar date on which the Employer and Contractor have signed the Agreement on the stamp Paper.
- g) 'Approval' wherever used in the specifications or schedule of Quantities shall mean, respectively, approved by or approval of the 'Accepting Authority' in writing.
- h) Electrical Maintenance Services means maintenance Of Substation and Other Related HT/LT Equipment, Operation of DG set and AC plant.

3.0 CONTRACTOR'S OBLIGATIONS

- 3.1 The Contractor shall be responsible for the proper upkeep and maintenance of the entire premises.
- 3.2 For any damage, breakage or loss of any equipment or property of the Bank, the Contractor shall have to replace the same at his own cost failing which the amount will be recovered from his security deposit or from other dues as payable to him by the Bank.
- 3.3 The Contractor shall keep a proper inventory of the items placed at his disposal by the Bank and the same shall be verified by the Contractor alongwith the representatives of the Bank.
- 3.4 The Bank reserves the right of free access through its authorized representative(s) to inspect the Electrical tools, Stores and equipment's for ensuring their wholesomeness, workability, quality and quantity at all times without any prior notice.
- 3.5 The Contractor shall keep the entire premisesclean, neat and hygienic. He shall use and provide at his own expenses the prescribed Electrical tools and other requisites for this purpose.
- 3.6 The Contractor shall not use or allow to be used the Electrical Maintenance premises or any part thereof for dwelling purposes and shall not allow any outsiders to loiter in and around the building without valid authority.
- 3.8 The Contractor shall also not use orallow to be used any facility, appliances, equipment provided by the Bank to him for any purpose other than providing Electrical Maintenance services as per the Bank's requirement.
- 3.9 The Contractor shall not without prior consent in writing by the Bank assign or sublet the contract or any part thereof to any other party provided that it shall not relieve the Contractor from any obligations, duty or responsibility under the contract.
- 3.10 The Contractor shall arrange for all cleaning materials for the purpose of cleaning and expenses in this regard shall be borne by the Contractor.

4.0 MANPOWER & WAGES

- 4.1 The Contractor shall make regular and full payment of wages / salaries and other payments to the employees and furnish necessary proof, as and when demanded by the officer-in-charge of the Bank/ concerned department of Central, State and local government agencies.
- 4.2 The Contractor shall be responsible for the compliance with applicable laws or which might become applicable, rules and regulations (latest amendment(s)) relating to Contract Labour (Regulations & Abolition) Act, 1970, Shops &Establishments Act, Factories Act, 1948, Employees Provident Funds & Misc. Provisions Act,1952,Payment of Gratuity Act, 1972, Payment of Bonus Act, 1965, Payments of Wages Act, 1936, Minimum Wages Act, 1948, Workmen's Compensation Act, 1923, ESI Act 1948 or such other Acts, laws or regulations passed by the Central/States, Municipal & Local Government, agency or authority.
- 4.3 The Officer-in-Charge or hisauthorized representatives will verifythe payment of wages by cross verifying the salary slips of all employees or any other proof as required by bank and shall record the following certification in the wage register.

 "Certified that salary forthemonth of ______ has been disbursed on _____ to the Electrical Maintenance Services Contractors' workers by the Contractor in accordance with the wages specified in Minimum Wages Act".
- 4.4 The Contractor shall also be liable to pay P.F. contribution, leave, salary etc and shall be liable to observe statutory working hours. The contractor shall note that neither the contractor himself, nor the persons employed by him shall have any right or privilege for employment benefit from the bank, nor they can make any claim in this regard.
- 4.5 Proper records shall be maintained by the Contractor with respect to the aboveacts and such other acts as may be applicable to Contractor's working and his workmen which would be subject to check from time to time, by the Officerin- Charge.
- 4.6 The optimum manpower requirement in the Electrical Maintenance Services may vary from time to time for efficient and timely Electrical Maintenance Services covering all categories of personnel required to be provided for Electrical Maintenance services, for which the contractor must, at all times maintain the needed manpower on shift basis
- 4.7 The Contractor shall maintain a register showing names and addresses of the persons engaged along with photographs of each person and shall produce the same for inspection on demand by Officer-in-Charge or such other persons so authorized by the Bank.

- 4.8 The Contractor shall arrange through the Bank's Security Department, on the advice of the Officer-in-Charge, to issue identity cards bearing photographs of the Electrical Maintenance employees for gate entry and shall exhibit prominently during working hours. The Electrical Maintenance staff shall also be liable for search on entry / exit.
- 4.9 The Contractor shall ensure that all Electrical Maintenance employees, during their working hours, wear proper and clean uniform as prescribed by the Bank.
- 4.10 The employees of the Contractor should be subjected to medical examination twice in a year at Contractor's cost by the Medical Officer nominated by the Bank. The employees should be free from all communicable, contagious infections and other diseases. In the event of any employee of the Contractor being found medically unfit, the Contractor shall arrange to replace him. Contractor has to submit medical certificate as and when required.
- 4.11 Nothing contained herein shall be construed to create a monthly tenancy or create any such interest in favour of the Contractor or their partners / representatives / employees in respect of Electrical Maintenance or the premises used by the Contractor in connection with or for the purpose of this agreement.
- 4.12 On termination of this agreement, the Contractor shall discontinue to use and handover vacant and peaceful possession of the Bank Premises of the said Electrical Maintenance or other premises together with the fixtures, equipments and articles in good condition to the Bank.

5.0 CONTRACTOR'S LIABILITY TOWARDS INDEMNITY

- 5.1 The Contractor shall indemnify the Bank for any loss occurred to the Bank by any act of commission & omission made by the contractor & or its employees and it includes against any claim under the Payment of Wages Act, 1936, and/or the Minimum Wages Act, 1948, Workman's Compensation Act, Factories Act or any statutory obligations arising out of any other Act or Acts (latest amendment(s))or on behalf of any person employed by him.
- 5.2 The Contract shall be in force for the period of 1 year stipulated in the contract and on the expiry thereof, it will be deemed to have been terminated automatically. Further, the contractor will not have any right either contractual or equitable to demand any fresh contract for another term or to continue the same for any period.
- 5.3 The contract will be initially for a period of three years and may be

extended / renewed as per the terms mutually decided by both the parties. On renewal, a fresh contract shall be executed and security deposit shall be retained till the validity of the contract.

5.4 In the event of any dispute arising out of the clauses mentioned above, the same shall be referred to the General Manager, General Administration Wing or any officer whom the General Managermay appoint for decisions and his decision shall be final and binding on both the parties.

6.0 MATERIALS

- 6.1 Contractor shall purchase and keep the required Electrical tools and safety equipment (like Helmet, Gloves etc)stock of good quality at his own cost. The Bank at its discretion through its authorized representative may check the stock, quality and quantity of all the items to see that the above is being compiled by the Contractor.
- 6.2 Contractor shall provide ladder upto 15 meters for maintenance of street lights and Auditorium lights.

7.0 MISCELLANEOUS

- 7.1 Contractor shall maintain the entire premises in clean and hygienic conditions. If the Contractor fails to engage sufficient staff for this purpose, the Bank will engage the staff on behalf of the Contractor at his risk and cost.
- 7.2 Contractor shall not exhibit or cause to be exhibited in the Electrical Maintenance premises any printed or written notices or advertisements of any kind, whatsoever except notices related to the working of the Electrical Maintenance Services, without the prior permission of the Bank.
- 7.3 The Bank reserves the right to deduct any amount that becomes payable by the Contractor in respect of the labour being employed by him for executing the job awarded, under any Act, or rules framed there under and in force from time to time. The same shall be recovered from bills payable to the Contractor as debt recoverable.
- 7.4 The Contractor shall undertake to provide comprehensive accident insurance policy coverage in respect of every employee employed by him. Contractor shall satisfy the Management of the same within the time prescribed by the Management but before the actual commencement of the job awarded to him.

- 7.5 If any of the labour employed by the contractor is found to be underperforming or anymisbehaviorisfound/reportedwhileonduty, Bank reserves the right to ask for a suitable substitute.
- 7.6 Contractor shall ensure that peace and order is maintained in the resting area / material handling room and if peace and order in Electrical Maintenance Services is disturbed due to lapse on the part of the contractor, a penalty of Rs.1000/- per occasion in a month for such lapse leading to disturbance of peace/order may be imposed by the Bank.
- 7.7 If the Bank finds that the Contractor is misusing the facilities provided by the Bank for carrying out the Electrical Maintenance services for any other purpose not covered under the contract, the Bank will be free to levy penalty which may extend toRs.5000/- or more per occasion.
- 7.8 If, on inspection, it is found that that the quantity / quality of Electrical tools utilized is not as per the norms of Indian Electrical Codes, a penalty upto Rs.1000/- may be imposed by the Bank for every such occasion.
- 7.9 Contractor would ensure that all the Electrical Maintenance staff employed by him would behave courteously and decently with employees of the Bank and also ensure good manners.
- 7.10 In the event of the Contractor suspending or abandoning Electrical Maintenance services without giving prior notice to the Bank, without handing over charge of the Electrical Maintenance tools (HT Equipment) entrusted to him by the Bank, the whole of security money and other dues payable to him shall stand forfeited to the Bank and he shall also be liable for such legal action deemed fit and proper for breach of contract and towards the loss of various accessories and furniture entrusted to the contractor.
- 7.11 No extra cost will be given for the HT Equipment testing in case of the HT faults.
- 7.11 The Officer in charge would be the final authority regarding Imposition of penalty under various circumstances as enumerated above. His decision shall be final and binding on the contractor.
- 7.12 If any tenderer withdraws his tender before the said period or makes any modifications in the terms and conditions of the tender which are not acceptable to the bank, before the said period of 190 days or before acceptance of offer, then the EMD submitted shall be forfeited.

- **8.0 AGREEMENT:** The successful tenderer will have to enter into an agreement with the Bank as per the format enclosed within 14 days after acceptance of the tender by the Bank.
- **9.0 SECURITY DEPOSIT:** The successful tenderer will have to deposit a security deposit of Rs. 30000.00 and the same shall not carry any interest.

10.0 TERMINATION OF CONTRACT

- 10.1 Canara Bank shall be at liberty to terminate the contract by issuingone month's noticetothe contractorwithoutassigninganyreasonwhatsoever. Bankshall not entertain any claim compensation by Contractor for such termination of Contract.
- 10.2 As regards unsatisfactoryperformanceornon-compliance with any oftheterms and conditions of the contract by the contract or or abandoning the work, Canara Bankshall have the right to terminate the contract for the thousand rearrange the work through other agencies at their risk and cost of the contractor and under such circumstances, these curity deposit paid by the contractor shall standforfeited.
- 10.3 The contractor shall follow suchAct, rulesand regulations (latest amendment(s)) of the State/Central Government that are in force and that may be framed from time to time for completion of work. Canara Bank shall not be responsible for anyinfringement of the various statutes in force by the contractor.
- 10.4 The contractor shall take, at his own cost the necessary license from statutory authorities in respect to this work. The expenses in completing the formalities in executing the agreement including execution on stamp paper will also bemet by the contractor.
- 10.5 Any additional items of work not covered by the contract shall be agreed by mutual discussion between the contractor and the Bank.
- 10.6 Statutory deduction towards income tax will be made as per rules.
- 10.7Income tax will be deducted in every monthly bill payable to contractor.
- 10.8 Prevailing Minimum Wages as notified by Regional Labour Commissioner (Central) has to be paid to the labourers employed by Contractor.
- 10.9 Paymenttothelabourersshallbepaidon7thofeverymonthand confirmed to the Bank.

- 10.10 The challans and other documents with regard to ESI/PF/pay slip should be submitted along with monthly bill.
- 10.11 Good and service tax charged by the Contract shall be reimbursed upon production of receipt of preceding month.

11.0 GENERAL

- 11.1 Contractor shall adhere to safety practices and avoid hazardous and unsafe working conditions and shall comply with the safety rules in force from time to time.
- 11.2The premises will be in possession of the Bank and the Contractor is permitted to enter the premises to carryout the Electrical Maintenance services only. If at any time the contract is terminated or the contract comes to an end or if the Bank decides that the contractor should not be allowed to carry out the Electrical Maintenance Services, in that event, the Bank will be entitled to restrain the contractor from entering the premises. The contractor will have no right or interest in the premises and other items given by the Bank.
- 11.3 Contractor shall use the Electrical tools and safety equipments only for the purpose of this agreement / contract and he shall not make any structural additions or alterations to the same.
- 11.4Contractor shall work under the supervision of the College -In-Charge, Centre of Excellence, Plot no 80, Sector 18, Gurugram 122015 and such other authorized officers of the Bank as may be nominated from time to time.
- 11.5 The Contractor and his workmen will be subject to police verification regarding their antecedents.
- 11.6 The contractor should not have been black-listed by any Government or Private Organization.
- 11.7The contract will not be given to any bidder for just being L-1. The capacity / experience / desired quality will also be considered. If any freak rates are quoted, the bank reserves the right to reject the offer quoted by the lowest tenderer and the EMD can be forfeited without any going notice or whatsoever.
- **Note:** Freak rate means the rates quoted for labour charges should not be less than the minimum wages recommended in the latest circular of central government. (Please refer latest circular under Ministry of labour and employment)

- 11.8The offer containing erasures of alterations will not be considered. There should be no hand written material, corrections or alterations in the offer. Technical details must be completely filled up. Conditional offers will be rejected.
- 11.9 The Contractor will have to provide the Bank with a list of employees categorywise located at the Electrical Maintenance Services and also their emoluments for the purpose of verification.
- 11.10 All the personnel engaged by the Contractor entering upon the Bank's premises shall properly be identified by badges, which may be worn by them at all times while in Bank premises. The Contractor will ensure that their employees do not remain in the premises beyond their normal working hours unless otherwise authorized. Any unauthorized presence in the premises beyond normal working hours will not be acceptable and Contractor upon receipt of complaint will have to immediately withdraw such employees from working in the Bank premises.
- 11.11 All the personnel engaged by the Contractor shall wholly and purely be in the employment of the Contractor and no claim of individual / collective nature on Bank's employment by any of the employees or claim of any nature on the Bank shall be tenable. The Contractor shall at all times keep the Bank fully and effectively indemnified against all actions, suits, proceedings, losses, costs, damages, charges, claims and demand in any way arising out of or during the course of anything done or committed / omitted to be done by the Contractor including the demand which the Contractor's employees individually / through their Unions may have raised against the Bank arising out of this agreement or as a result of the termination therefor or earlier determination of the Contract.

12.0 LABOUR

- 12.1The Contractor shall employ suitable labour to maintainthe required qualityof cleaning to the satisfaction of the Bank.
- 12.2 The contractor shall furnish to theBankat the intervals specifiedby Bank, a distribution of the number and description of labour employed in carrying outworks. The Contractor shall submit on the 4th and 19th of every month to the Bank as tatement showing in respect of the second half of the preceding month and the first half of the current month (i) the number of labourers employed by him on the work (ii) their working hours (iii) the wages paid to them (iv) the accidents that occurred during the said fortnight showing the circumstances under which they happened and the extent of damage and injury caused by them and (v) the number of female workers who have been allowed maternity benefits as provided in the

maternity benefitAct,1961with their latest amendment(s)orRulesmadethereunderandtheamountpaidto them.

- 12.3 Thecontractorshallapplyandobtainlicenseunderthecontractlabour(R&A) Act 1970 with their latest amendment(s) and complywiththerelevantprovision of this Act, in respect of the labour employed by himfor executing this contract. The contractorshall furnishnecessary returns to the authority through Bank.
- 12.4 The minimum age of the labour employed shall not be below 18 years.
- 12.5ThecontractorshallcomplywiththeprovisionsoftheWorkmen'scompensationact1923.the paymentoftheWagesAct1936, Factories Act, Minimum Wages Act 1948, EmploymentofChildrenAct1938, **Employers** Liability Act 1938, Industrial DisputesAct1947andotherActsCentral orStates, that may be applicable to him. Heshall beliabletopavallsuch sums thatmaybecomepayableas sum, or contribution, compensation, penalty, fine or otherwise, which the provision of the saidacts, toor onbehalfof anyworkmenemployed bythe contractor byan authorityempowered undertherelevant Act. Any costincurredby CanaraBank in connection with any claim or proceeding sunder the said Actsor inofloss, injuryorim proper performance of this contract by the contractor, is work men, servant andanymoneywhichmaybecomepayabletoCanaraBankasaforesaid shallbedeemedto bedeductedbyCanaraBankormayberecoveredbythe management of Canara Bank from the contractor in the other manner.
- 12.6 Thecontractorshouldtake independent code numbers under EPF Act1952with their latest amendment(s) and ESI Act1948andshallcoverhisworkmenunder theemployee'sprovidentfundschemes and Employees State Insurance Act 1948 with their latest amendment(s) and show proof of payment of subscriptions/contributions to the concerned authorities. Both in respect of ESI/EPF the contractor shall obtain necessary declarationformsfromhis employees and obtain individual insurance and PF number and shall furnish to the Bank every month, necessary proofs for having made remittance of ESI and PF contributions in respect of all contract labourers engaged by him.
- 12.7 AsregardsEmployeesStateInsurance Act, the contractorshallsubmitPhotostat copiesofthe challansofremittanceofthe contributions (boththe employee's contributionsandhisowncontributionthereon) to the ESI Corporation inrespect oftheemployeesengagedinCanaraBankbyhimforthiswork fortherelevant period before any payment is released by Canara Bank.
- 12.8 AsregardstheEmployeesprovidentfundandmiscellaneousprovisionAct1952 and rules and regulations and schemesframedthere under, theyshallbeliableto payemployees compensation under the Actinrespect tofalllabouremployedby himfor theexecution of the contract. For this purpose, he shall indicate the code

number obtained by him from the Regional Provident Fund Commissioner and produce the Photostat copy of the challan receipt of monthly remittance. He shall also furnish such returns as a reduce under the Act to be sent to the appropriate authorities through Canara Bank.

- 12.9 Thecontractoris requiredtotakeInsuranceforalltheworkersemployedonthe works towards paymentsforworkmencompensation. TheInsurancehastobetaken within15 daysoftheawardofworkandhas tobeprovidedatthesigningofthe agreement. The contractorshallbefully responsiblefortheconsequencesarising out of defaultandBank may treatit as breachofContract andreserves therightto terminatethe Contract.
- 12.10Thecontractorshallpaywagestohisworkmenattherates as applicable under Theminimum Wages Act as perCentralGovernmentguidelinesforunskilledandforsemiskilled/eguivalent categories. The contractor shall provide the proof of disbursement of the wages and obtain their in the signature payment registeronorbefore7thofeverymonth.Ifitfalls on Sunday payment shall be made on previous day.
- 12.11 Thedurationofdutyiseighthoursperdayperperson. Tokeeptheefficiency and alert ness the overtime will be kept to the barest minimum.

13.0 SAFETY CODE - RESPONSIBILITIES OF THE CONTRACTOR IN RESPECT OF SAFETY OF MEN, EQUIPMENT, MATERIAL AND ENVIRONMENT

Before commencing the work, contractor submits a SAFETY PLAN 'to the authorized Canara Bank official. The 'SAFETYPLAN' shall include in detail the measure that would be taken by the contractor to ensure safety of men, equipment, material and environment during execution of the work. The planshall takecare to satisfy all requirements specified here under. The contractor shall submitSafetyPlanalongwithhisoffer. During negotiations before placing of work order and during execution of the contract Canara Bank shall have right to review and suggest modification in the SafetyPlan. Contractor shall abide by Canara Bank decision in this respect.

- 13.1 The contractor shall take all necessary safety precautions and arrange for appropriate appliances as perdirection of Canara Bank or its authorized official sto preventloss of human lives, in juries to personnel engaged and damage to property and environment.
- 13.2 The contractor shall provide to its work force and ensure the use of the following personal protective equipment as found necessary and as directed by the authorized Canara bank officials:-

Safety Helmets confirming to IS-2925:1984

Safety Shoes conforming to IS-1989:1978.

Eye and Face protection devices conforming to IS-8520:1977 and IS-

8940:1978.wherever required

Hand and body protection devices conforming to: IS-573:1975

IS-6994:1973 IS-8807:1978 IS-8519:1977

- 13.3 Where it becomes necessary to provide and/or store petroleum products, chemicals andliquid or gaseous fueloranyothersubstancethatmaycausefireor explosion, thecontractorshallstorethesamesafelyasperthe directionsofthe Bank.
- 13.4 All electrical equipment's connection and wiring for equipment's, its distribution and use shall confirm to their requirement of the Indian Electricity Actand Rules. All electrical appliances including portable electric tool/equipment used by the contractor shall have safe plugging system to source of power and be appropriately earthed.
- 13.5 The contractor shall be held responsible for any violation of statutory regulations local, state orcentraland CanaraBank instructions that mayendanger safetyofmen, equipment, material and environment in his scope of work or another contractor's or agencies. Cost of damages if any, to life and property arising out of such violation of statutory regulations and Canara Bank instructions shall be borne by the contractor.

14.0 ARBITRATION

- 14.1Alldisputesordifferences of any kind whatsoever which shall at any timearise between the partiesheretotouchingorconcerningtheworks or the execution or maintenance thereof of this contractor the rights touching or concerning the works or the execution of maintenance thereof of this contract or the construction remaining operation or effect thereoforto the rights or liabilities of the parties orarisingout of or in relation thereto whether during or after determinationfor orbreachofthecontract(otherthanthoseinrespect enclosure ofwhichthedecisionofanyperson isbythecontractexpressed tobefinaland binding)shallafterwrittennoticebyeitherparty tothecontracttotheotherof themandtoCanaraBankhereinaftermentionedbereferredfor adjudicationtoa sole Arbitrator to be appointed as hereinafter provided.
- 14.2Forthepurpose of appointing the sole Arbitrator referred to above, Canara Bank willsendwithinthirty days of receipt of the notice, to the contractor a panel of

threenamesofpersons who shall be presently unconnected with the organization for which the work is executed.

- 14.3 The contractor shall on receipt of the namesofaforesaid, selectanyoneofthe persons named to be appointed as a sole Arbitrator and communicatehisnameto Canara Bank within thirty days ofreceiptofthenames. CanaraBankshall there upon without any delay appointthesaidpers on sthe Sole Arbitrator. If the contractor fails to communicate suchselection as provided abovewithinthe period specified, the competent authority of Canara Bank shall make the selectionand appoint the selected person as the Sole Arbitrator.
- 14.4 **IfCanaraBankfails** tosendtothecontractorthepanelofthreenamesas aforesaidwithintheperiodspecified, the contractor shall sendtoCanaraBanka panelofthreenamesofpersonswhoshallall beunconnectedwitheitherparty. Canara namedasaforesaidselectanyoneofthe Bankshallon receipt of the person'snameand appoint him as the Sole Arbitrator. If CanaraBankfailsto selectthe personand appointhimas the Sole Arbitrator within 30 days of receipt of panelandinformthecontractoraccordingly, the the contractor shall entitledtoappointoneof the persons from the panels the Sole Arbitrator and communicate his name to Canara Bank.
- 14.5 IftheArbitratorsoappointedisunableorunwillingto actorresignshis appointment tovacatehisofficedueto anyreasonwhatsoever another Sole Arbitratorshall beappointedasaforesaid. Theworkunderthe Contractshall, however, continueduring the arbitration proceedings and no payment due or payable to the contractorshall be withheld on account of such proceedings. The Arbitratorshall give as eparatere as one daward in respect to each dispute or difference referred to him. The venue of arbitration shall be such place as may be fixed by the Arbitrator in his sole discretion.
- 14.6 Thefeesand expenses, if any, of the Arbitrator shall, if required to be paid before the award is made and published, be paid half and half by each of the parties. The Arbitrator may direct to and by who mand in what manner the cost of the reference and of the award including the feesand expenses or any part thereof shall be paid and may fix or settle the amount of costs to be so paid.
- 14.7 The award of the Arbitrator shall be final and binding on both the parties. Subject to the aforesaid, the provisionsoftheArbitrationand Conciliation Act, 1996with their latest amendment(s)oranystatutory modification orre-enactment thereof and the rules made hereunder, and for the timebeing in force, shall apply to the arbitration proceeding under this clause.

- 14.8 "The contractor shall indemnify the bank for any loss occurred to the bank by any act of commission & omission made by the contractor & or his employees and it includes against any claim under the Payment of Wages Act, 1936, and/or the Minimum Wages Act, 1948with their latest amendment(s), Workman's Compensation Actwith their latest amendment(s), Factories Actwith their latest amendment(s) or any statutory obligations arising out of any other Act or Acts or on behalf of any person employed by him."
- 15.0 **PAYMENTTERMS:** The payments shall beon monthly basison format prescribedby Bank, subject toproduction of Attendance Register, Proof of payment of wages, ESI, PF and filing returns to Statutory Authorities.
- 16.0 The successful tenderershall execute the agreement (Annexure 7) on a stamp paper of appropriate value within four teendays from the date of acceptance of the offer.
- 17.0 **FORFEITUREOFEMD:** Bankreservestherightstocanceltheorderandforfeitthe EMD if,
 - Security Deposit is not submitted within the stipulated time;
 - Agreement is not entered withinstipulated time;
 - The contract will not be given to any bidder for just being L-1. The capacity / experience / desired quality will also be considered. If any freak rates are quoted, the bank reserves the right to reject the offer quoted by the lowest tenderer and the EMD can be forfeited without any going notice or whatsoever.
 - If any tenderer withdraws his tenderbefore THE SAID PERIOD (90 days) or makes any modifications in the terms and conditions of the tender which are not acceptable to the Bank, then the Bank shall, without prejudice to any other right or remedy, be at liberty to for feitfull value of the EMD as a foresaid.

The entire internal and external premises shall be spic and span before 09.30AM every day.

- 5. Allthe cleaning materials such asbrooms, mops, buckets and consumables required for providing the above service has to be borne by the vendor. However agency has to ensure the proper quality of the cleaning materials and consumables supplied by the Bankbyre cording the usage of the materials in a register. The same will be verified and authenticated by the Bank of ficial in charge at any point of time.
- 6. The contractor shall bring alltherequired equipment for cleaning like machines, vacuum cleaners and other equipment to be used for the Electrical Maintenance and cleaningworks. Maintenance of suchequipment including he cost of spares is the responsibility of the contractor.

- 9. Theworkersandthestaffofthecontractorworkinginthepremiseswillhaveto maintain with proper discipline. The contractor shall provide his workers with proper safety appliances and equipments and Canara Bank shall not be responsible for accidents and injuries caused to his labour during the course of their work.
- 10. ForworkingintheCentre of Excellence, building, the workmenand supervisory staffofthe contractor shall obtainentrypass issued by the security department ofCanara Bank.Allthestaffofcontractormayberequiredtoundergosecuritycheckas per the rules and regulations of Bank from time to time.
- 11. Theworkers/labourersemployedbyyourcompanywillbecheckedbyBank'sSecurity personnel if required.
- 12. The facility Manager and supervisors shouldbe provided with mobile phones for communication.
- 13. All the labourers (male and female) should maintain personal hygiene, nails should be cut, neatly groomed and should maintain strict discipline within the building premises.
- 14. The contractor is required to engage the following categories of workers dailyfor the subject work in each shift:
