1. The cars will be sold on “**AS IS WHERE IS**” condition and the bank shall not be responsible for any defects latent or otherwise, damage, decay or any missing parts of the vehicle. Buyers can inspect the vehicles before offering their tender.
 2. Intending buyers should submit their offers in the prescribed format as enclosed in closed/sealed covers, which has to be submitted at **CANARA BANK, CIRCLE OFFICE PUNE, F.P. 790(Part), Shivaji Road, Shivaji Nagar, Pune-411005** along with the **EARNEST MONEY DEPOSIT (EMD)** of Rs 15000/- by way of Demand Draft drawn in favour of **CANARA BANK, CIRCLE OFFICE PUNE**.  6. The EARNEST MONEY DEPOSIT will be refunded to the unsuccessful offerors. No interest shall be payable on EMD.
 7. In case of acceptance of the offer by the Bank, the EMD shall be adjusted against the total price offered by the successful offeror subject to, however payment of the balance before the stipulated date.
 8. The acceptance of the offer will be intimated to successful offeror/bidder by Circle Office Pune and such notice shall be deemed to be personal notice of information to the successful offeror and shall be binding on him.
 9. The successful offeror shall pay the balance amount forthwith on the day on which the acceptance of the offer is notified/within the time limit permitted. The bank shall require a minimum of 30 days time for intimating the acceptance of the offer.

13. The delivery of the vehicle will be made only after receipt of NO OBJECTION CERTIFICATE issued by RTO and on payment of total price. NOC is to be obtained by intending purchaser. However, necessary documents will be provided by the bank to obtain NOC.
14. The Bank reserves the right to reject any offer without giving any reasons thereof.
15. The bank shall not be responsible for any loss, damage decay and theft or removal of parts from it or in any manner whatsoever. **Insurance of the vehicle will be retained by the Bank.**
