1	BOQ	Kindly confirm whether GST will paid extra on the quoted amount or whether it is to be included in the rates.	GST will be paid extra over the rates. Thus the rates to be quoted should be exclusive of GST but inclusive of any/all other tax/es.
2	BOQ	The audited Balance sheet for the financial year 2019-20 cannot be provided since March onwards till June there has been a lockdown due to Covid 19 , and still there are problems and therefore the MOF , GOI has extended the last date of submission of audited balance sheet till Nov 2020. However, we can provide self attested copy of Annual turnover along with the GSTR Returns filed as supporting document.	Self attested copy of Annual turnover along with the GSTR Returns filed as supporting document is to be provided. However, in cases where audited balance for FY19-20 cannot be provided, self attested copy of Annual turnover along with the GSTR Returns filed as supporting document is to be provided. Also, audited balance sheet of last 3 years i.e. 2016-17, 2017-18 and 2018-19 is required.
3	BOQ	<p>The thickness of the Ply mentioned in the BOQ is not matching the thickness of ply in the technical specification of the mentioned items of the BOQ.</p> <p>Kindly clarify the thickness of ply to be used and also whether if there is any ambiguity between BOQ and Technical Specifications, what takes precedence?</p>	<p>The thickness of plywood on both side of aluminum framing in the Item no.33,34,35,36,37,38,39 to be taken as 6mm.</p> <p>The flushdoor sheet in item no. 44 and 45 SHOULD NOT be provided with plywood on either side. The thickness of the flushdoor is to be taken as 35mm</p> <p>In all other cases, the BOQ should be considered to preside over Technical Specifications.</p>
